Position Summary

Ensure the smooth flow of materials both raw & finished on the production floor. Operate forklift in a safe and careful manner. Observe all corporate safety rules, regulations and established procedures, including those established for forklift operations.

Essential Responsibilities

- Operate forklift to transport a variety of parts and materials from one department to another, or from one work station to
- Ensure that loads are stacked properly for safe transportation, pick up load - holding load as closely to the ground as conditions permit - and position load safely and carefully at designated drop-off Check oil level, battery, and make other routine checks of vehicle daily. Change tanks of propane gas as required. Report any equipment malfunctions to the supervisor.
- Perform other duties as assigned, including pulling and stocking parts, stock control, preparation for new work, dumping scrap, transporting dies, loading coils, removing unnecessary items from floor,
- Position forks, lifting platform, or other lifting device under, over, or around loaded pallets, skids, boxes, products, or materials or hook tow trucks to trailer hitch, and transport load to designated Maintain work area in a clean, safe and orderly condition.
- Wear all personal protective equipment as required.
- Demonstrate continuous effort to improve operations, decrease turnaround times, streamline work process, and work cooperatively and jointly to provide quality seamless customer
- Participate in continuous improvement and assist in its implementation on an ongoing

Physical Demands & Work Environment

Physical Demands

The position is in the factory and involves walking, standing for long periods of time throughout the day. It requires being able to lift up to 50 pounds, and push/pull up to 75 pounds. Involves making continuous or repetitive arm-hand movements while operating a press. Stooping/bending/twisting is required on regular basis. Fast-paced environment, usually work standard 40-hour weeks, but overtime may be necessary as work load's dictate. This may include weekdays, weekends and/or holidays.

Work Environments

Work performed in a shop environment and regularly exposed to dust, odors, oil, fumes and noise. It requires wearing personal protective or safety equipment. Requires working in non-air-conditioned variable temperature factory setting. Employees may be subject to random drug and alcohol testing under FAA regulations
